**ORDINANCE NO. 3602-09**

**AN ORDINANCE ADDING SECTIONS 18-38 AND 18-39  
OF THE CODE OF ORDINANCES OF THE CITY OF LOVES PARK**

WHEREAS, Section 18-38 of the Code of Ordinances of the City of Loves Park regulates wildland located within the City; and

WHEREAS, the City of Loves Park desires to ensure regulation of such land; and

WHEREAS, the City desires to add said section.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVES PARK, WINNEBAGO COUNTY, ILLINOIS AS FOLLOWS:**

**SECTION ONE:** Section 18-38 of the Loves Park City Code is hereby added to read as follows:

The International Wildland-Urban Interface Code, 2006 edition, including Appendix Chapters A, B, C, D, E, F, G, and H, as published by the International Code Council, be and is hereby adopted as the *Wildland-Urban Interface Code* of the City of Loves Park, in the State of Illinois, for regulating and governing the mitigation of hazard to life and property from the intrusion of fire from wildland exposures, fire from adjacent structures and prevention of structure fires from spreading to wildland fuels as herein provided; providing for the issuance of permits and collection fees therefor; and each and all of the regulations, provisions, penalties, conditions and terms of said Wildland-Urban Interface Code are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes prescribed in Section Two of this ordinance.

**SECTION TWO:** Section 18-39 is added as follows:

**Section 101.1 shall be revised as follows:**

**101.1 Title.** These regulations shall be known as the *Wildland-Urban Interface Code* of the City of Loves Park, hereinafter referred to as “this code”.



**SECTION FOUR:** All ordinances, resolutions, or parts of ordinances in conflict herewith are hereby repealed.



**SECTION FIVE:** This ordinance shall be in full force and effective on January 1, 2010.
